Definition: "Parent/s" means the lawful parent, caregiver and other lawful or apparent representative of the student.

Entry Requirements

1. Students who want to study at Woodcroft College must have attained at least the equivalent level of study in their own country.
2. Students must submit their past two years of school reports for assessment by senior staff at the College. These must be translated into English if written in another language.
3. Students must have acceptable results in the subjects that they wish to study at Woodcroft College.
4. Students are generally required to undertake 5, 10, 20 weeks of Intensive English in order to prepare them for their mainstream course. The time required is dependent on their level of English on entry to the College.
5. Students will be required to participate in an online interview prior to acceptance and complete a written English test.
6. Year 10 students may be required to stay for three weeks of Summer School, which is a bridging course for preparation for study in the IB or SACE programs.
7. The College's Student Services Policy requires Parents to provide information relevant to any special needs that an applicant may have at the time of the Registration of Interest and/or before Enrolment. Failure to disclose this information could result in the student's placement being delayed or withdrawn.
