COLLEGE ENROLMENT FEES

Registration of Interest Fee

A \$60 non-refundable fee applies when submitting a Registration of Interest to be placed in the College wait pool from ELC to Year 12.

Enrolment Fee

A non-refundable enrolment fee of \$700 applies to all new students and is payable on acceptance of the Offer of Enrolment for ELC to Year 12. Please note the Enrolment Guarantee Fee for enrolments from 2027 will be \$750.

For families accepting a place in ELC only with no transition to school, the Enrolment Guarantee Fee is \$150.

Sibling Discount

Sibling discounts increment progressively in accordance with the number of siblings attending the College at the same time. The discount is applied to the Annual Student Charges (Reception to Year 12) as follows:

- 15% for the second child in a family
- 30% for the third child
- 45% for the fourth child

Annual Family Charge (Reception to Year 12)

Capital Levy: \$820

Charged once a year, per family, regardless of the number of children attending the College. The Capital Levy helps fund the ongoing development of the College.

Other Fees

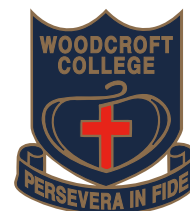
Other fees will be incurred for students undertaking VET, participation in excursions and extracurricular activities and for books and electronic resources.

EARLY LEARNING CENTRE

Preschool/Kindergarten	Full Fee Per Day
8.30am to 3.30pm	\$130

Extended Care Options	Full Fee Per Day
9 hour: 8.00am to 5.00pm	\$137
10 hour: 7.30am to 5.30pm	\$142
Full day: 6.45am to 6.15pm (permanent)	\$145
Full day (casual – subject to availability)	\$155

(Late fees apply for every minute of care outside of session times at a rate of \$15 for every 15 minutes or part thereof.)

The ELC is an approved Long Day Care Provider. Eligible families may access the Child Care Subsidy (CCS) for ELC fees.

The ELC is open 50 weeks of the year (closure is two weeks over Christmas), however attendance during term breaks is optional. Families who are enrolled for the full 50 weeks are eligible to receive a discount of 25% off their weekly fee for two weeks per year.

Minimum Attendance

3-Year-Old Flying Start Preschool: Two days per week[^]

4-Year-Old Kindergarten: Three days per week

[^]As of 2027, the minimum days per week for the 3-Year-Old Flying Start Program will be three days.

OUT OF SCHOOL HOURS CARE: RECEPTION TO YEAR 6

Program	Fee Per Session/Day
Before School Care: 6.45am to 8.30am	\$16 (permanent bookings) \$20 (casual subject to availability)
After School Care: 3.15pm to 6.15pm	\$26 (permanent bookings) \$30 (casual subject to availability)
School Holiday Program/Pupil Free Day	\$75

(Late fees apply from 6.15pm to 6.20pm at a rate of \$26 per child and \$3.00 per minute thereafter.)

The OSHC is an approved childcare provider. Eligible families can access the Child Care Subsidy (CCS).
